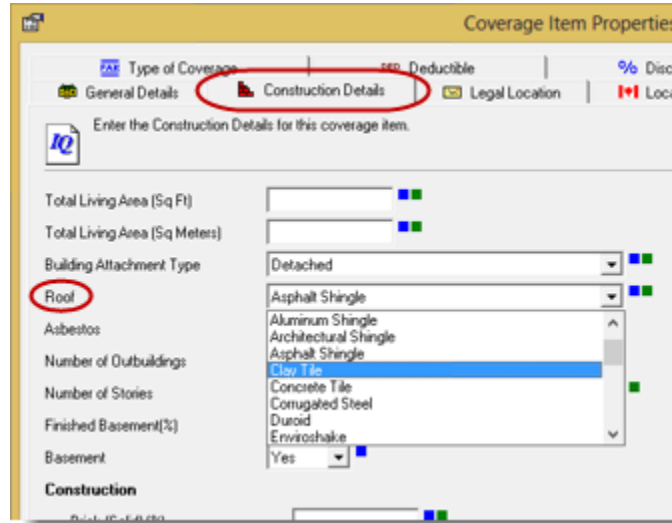
1. Intact/Novex Rating Enhancements (MB)

Intact has enhanced their perils-based rating for homeowners, additional residence (home), and seasonal dwelling broad policy, and brokers in Manitoba who write business with Intact/Novex will have access to these enhancements effective May 1, 2014 for new business and renewals.

To accommodate these enhancements, additional options and fields have been added in TBW for Construction Details and Sewer Back-Up as follows.

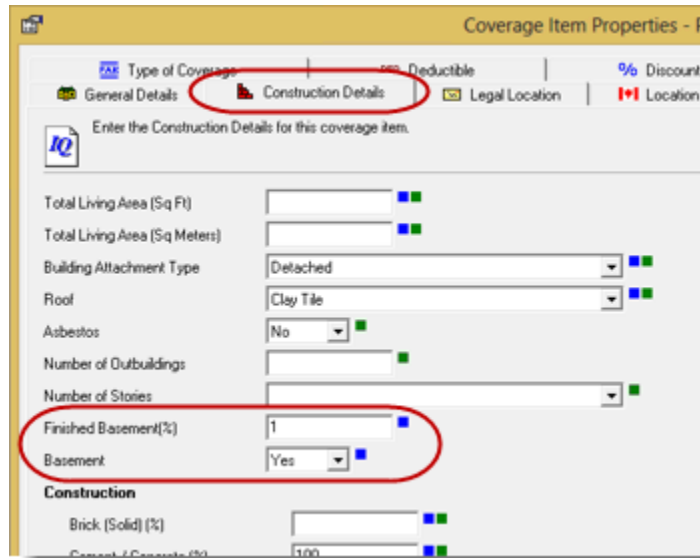
- **Roofing Material** – Additional items (*Clay, Concrete, Slate, and Rubber*) have been added to the **Roof** drop-down menu on the Construction Details tab (see Figure 1.1).

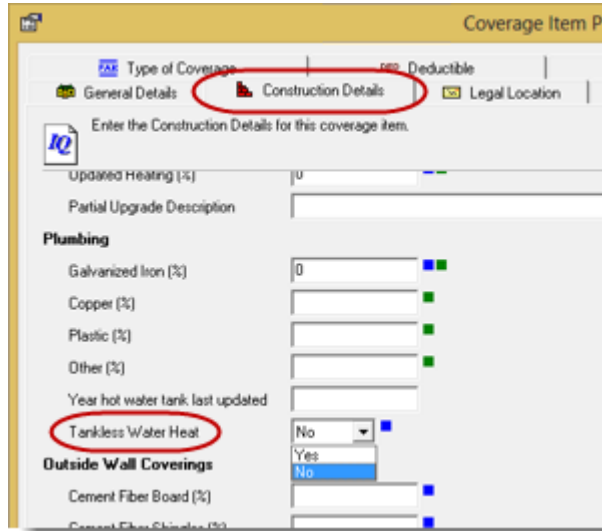
- **Basement and Finished Basement (%)** fields are now available on the Construction Details tab (see Figure 1.2).

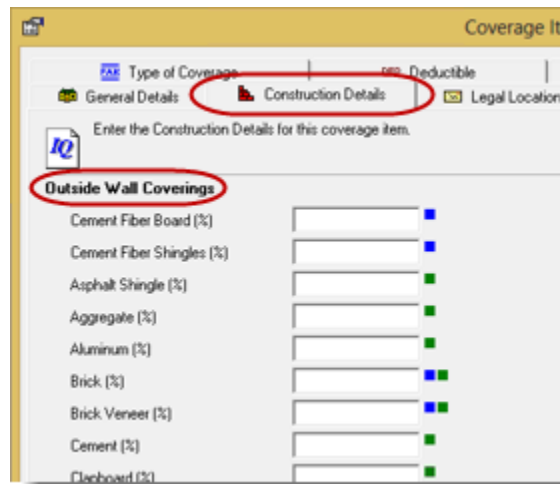
- A **Tankless Water Heater** drop-down menu is now located in the **Plumbing** section on the Construction Details tab (see Figure 1.3).

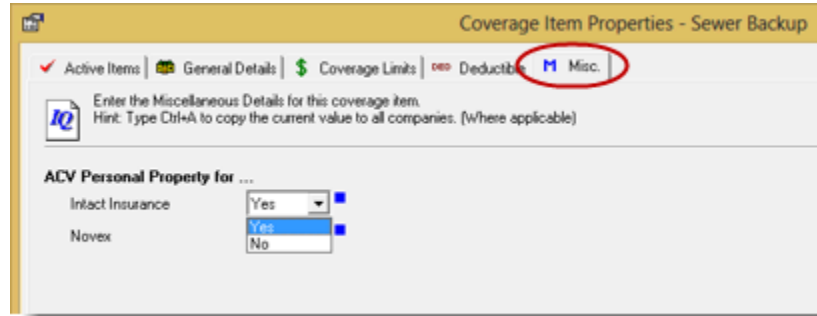
- The **Exterior Wall Finish/Outside Wall Coverings** section has been enhanced with additional options (*Stucco, Brick Veneer, Solid Brick, Stone Veneer, Solid Stone, Cement Fiberboard, and Cement Fiber Shingles*) (see Figure 1.4).
 - Please note the Exterior Wall Finish must be over 50%.

- The **Actual Cash Value Personal Property** option has been added to Sewer Back-Up.
 - After selecting the Coverage Limit and Deductible for Sewer Back-Up in the Coverage Item Properties window, click the **Misc.** tab and make the appropriate selection in the **ACV Personal Property** drop-down menu(s) (see Figure 1.5).
